Section I: Services to be performed by Itasca Woodland Services:

- Estimate volumes of timber to be harvested
- > Prepare and distribute formal bid for timber harvest and/or assist in obtaining a contractor to pay for and complete the harvest
- Create formal contract for timber harvest and oversee proper execution of harvest according to the terms outlined in the contract.
- > Ensure harvest boundaries fall within landowners property lines
- > Track and record actual volumes of timber removed during harvest
- > Facilitate prompt payment to landowner from harvester.

Section II:

In return for the aforementioned services, the landowner agrees to pay Itasca Woodland Services, Inc. a total of 15% of the total gross income received from the value of the timber harvested. There is a \$1500.00 minimum charge for any timber sale, with \$750 due immediately upon timber sale bid invitations being sent out or buyer is secured with a contract, whichever comes first. Subsequent payments are to be made to forester within 15 days of receipt of payment from timber buyer. IN WITNESS WHEREOF, the parties have set their hands on the dates shown below. 

Overview Map of harvest locations



(Red Stars are pre-existing landing sites from about 2007-2010, or natural openings)





SECTION 11: THE SELLER AGREES TO SELL and the Purchaser agrees to buy, under the terms and conditions hereinafter stated, all the timber marked or designated by the Seller, as estimated in SECTION V, on certain lands held by the Seller as described in Section 1.

SECTION III: THE PURCHASER AGREES TO PAY the seller the amounts specified in Section I, more or less, as may be determined by the actual scale at the rate and by the method specified in SECTION V. The Purchaser also agrees to pay the Seller a separate refundable deposit as specified in SECTION I, to guarantee the performance of SECTIONS IV, V and VI.

SECTION IV: UPON RECEIPT OF THE DOWN-PAYMENT, and the signature of both parties, this agreement becomes effective. The Purchaser agrees to pay the Seller a down-payment in the amount specified in SECTION I when the contract is signed. The balance of the actual value of timber removed shall be paid within 15 days of completion of logging operations and the receipt of all consumer load reports for this sale.

SECTION V: ALL TIMBER DESIGNATED BELOW SHALL BE CUT and removed before the date specified in SECTION I unless extension of time is requested and granted in writing. Sale expiration shall occur on this date or before if all products have been cut, removed, and final payment completed. The Purchaser is liable for the full bid price for all timber listed below, including any uncut or not removed at sale expiration. This liability shall continue notwithstanding injury to the timber from natural causes. Acts of God, or human acts including vandalism or theft. All rights to remaining products, cut or uncut, revert to the Seller at sale expiration.

SECTION VI:

Cutting Regulations:

No sale operations allowed between March 15th and August 15th. Operate during non-rutting soil conditions only.
Harvest operations may be suspended at the discretion of Itasca Woodland Services, Inc. (hereafter IWS) or its representative(s). Gouges caused by dragging trees is NOT rutting.

Damage to property that would justify withholding of performance deposit includes, but is not limited to:

- · Broken gates, deer stands, or other fixed, manmade structures on or adjacent to property.
- Unrepaired road rutting or unrepairable rutting in the woods. Road rut tolerance = Up to 4 inches deep with a maximum rut length of 15 feet. Harvest and surrounding area(s) rut tolerance = Up to 8 inches with a maximum rut length of 15 feet.
- Damage to residual trees that exceeds typical industry standards, as determined by IWS.
- Any other unreasonable damage to the environment, real or personal property that will incur an expense to replace or restore said damaged feature to its original condition. "Unreasonable" damage will be determined by IWS.

General Sale-wide Cutting Regulations:

- Open and clear communication must be maintained with the forester at all times regarding estimated starting and finishing dates, procedural problems and questions, etc.
- Landing sites and skid trails must meet with the approval of the landowner and/or forester.
- Merchantable trees listed for sale (cut or standing) that are not utilized will be charged double stumpage rates






McGarty NE Harvest Units
