Wildlife Manager Report

Deer Permit Area 604 contains all of former DPAs 242 and 247 along with portions of 155 and 246. This DPA is designaged as a CWD Management Zone and was created following the finding of CWD in a wild deer in January of 2019. This area is in the heart of the Brainerd Lakes area. Mostly wooded, this permit area contains both pine and hardwood forests with lakes dotting the landscape. Since this DPA is designated as a CWD Management Zone, mandatory carcass movement restrictions are in place for all deer, including fawns. DNR-provided dumpsters will be available for hunters to dispose of carcass waste properly. CWD testing is voluntary during the entire archery, firearms and muzzleloader seasons by providing the head of harvested deer at designated self-service sampling stations. There is no restriction on the number of disease management permits purchased (\$2.50 each), which may be used to harvest antlerless deer. This DPA is also open durinig the Early Antlerless season in October. Hunters in this area may only tag one legal buck.
