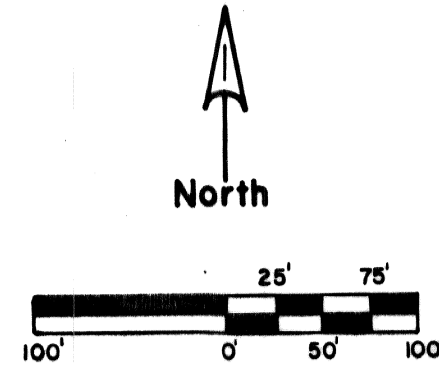


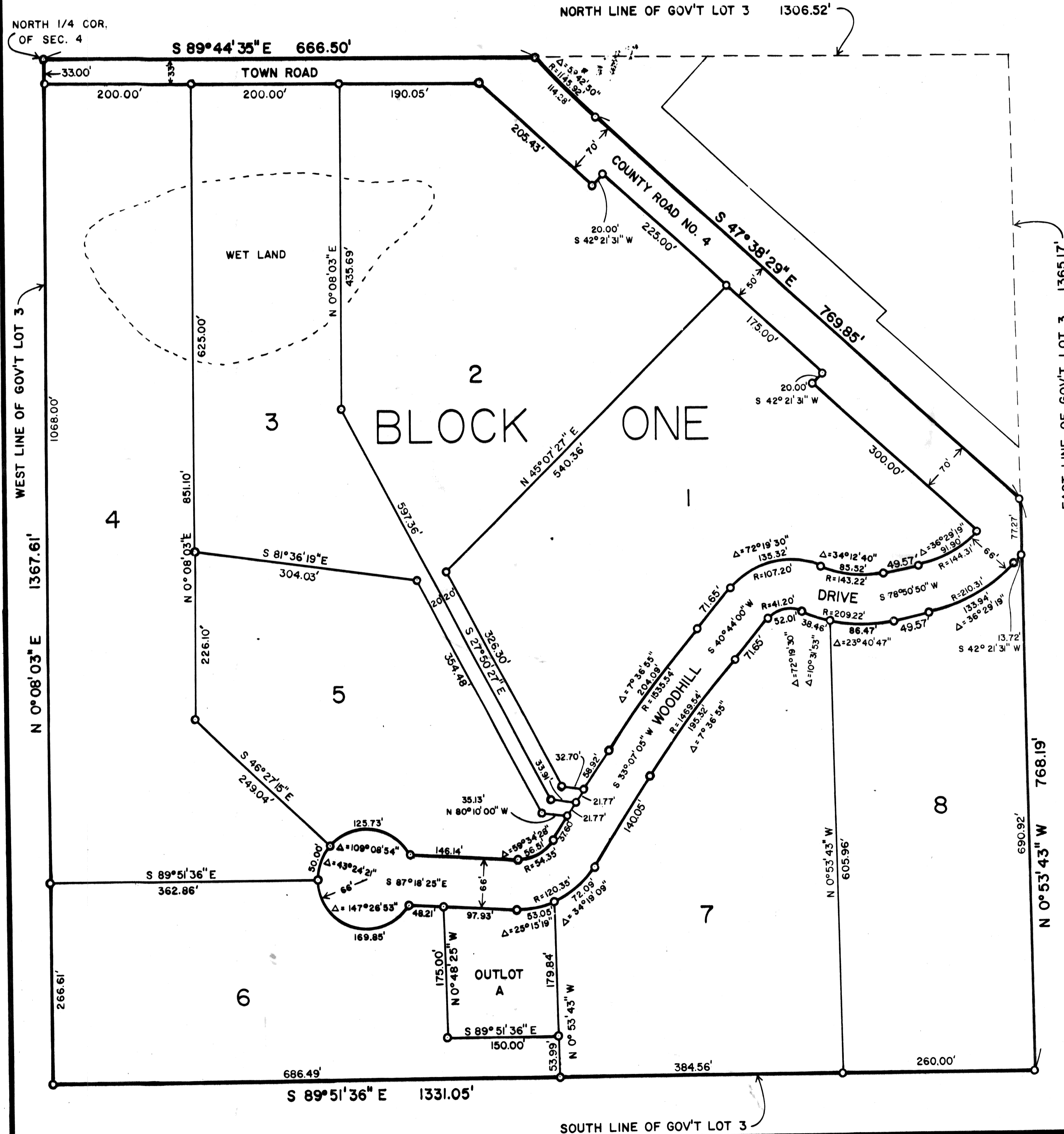
WOODHILL

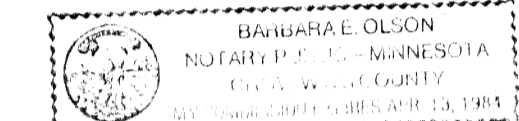

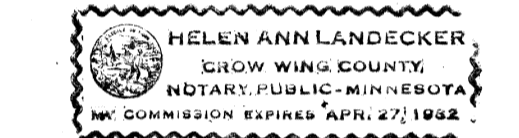
